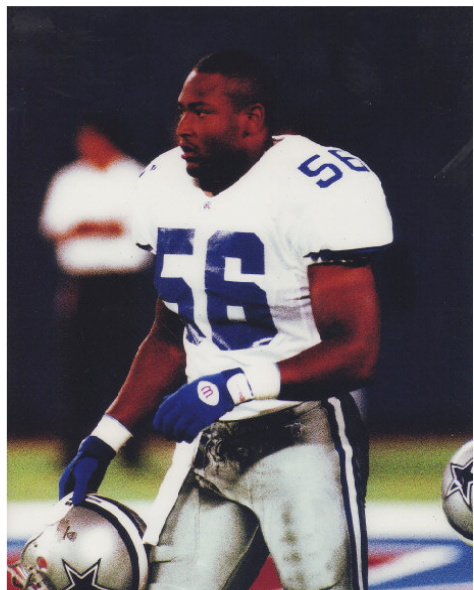

Waiver of Liability and Hold Harmless Agreement

In consideration for receiving permission to participate in the NFL Character Camp, I hereby release, waive, and discharge and covenant not to sue NFL Character Camp, their officers, servants, agents, employees or assignees (herein afterin referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of relating to any loss, damage, or injury including death, that may be sustained by my child or to any property belonging to my child, whether caused by the negligence of the releases, or otherwise while participating in such activity, or while in, or upon the premises where the activity is being conducted. To the best of my knowledge, my child can fully participate in this activity. I am fully aware of the risks and hazards connected with the activity including but not limited to the risks as noted herein, and I hereby elect to voluntarily allow my child to participate in said activity, and to enter the above named premises and engage in such activity knowing that the activity may be hazardous to my child. I further hereby agree to indemnify and hold harmless the releases from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activity, whether caused by negligence or releases or otherwise. It is my expressed intent that this release and hold harmless agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns and personal representative, if I am not alive. I also agree that this waiver of liability and hold harmless agreement shall be constructed in accordance with the laws of Texas. I understand that NFL Character Camp will not be responsible for any medical costs associated with any injury that may be sustained. I further agree to become familiar with the rules and regulations of NFL Character Camp regarding student conduct and not to violate said rules or any directive or instruction made by the person or persons in charge of said programs and that I assume the complete risk of any activity done in violation of those rules and regulations. I also understand that I should am urged by NFL Character Camp to obtain adequate health and accident insurance to cover personal injury to my child which may be sustained during the program. In signing this release, I acknowledge and represent that I have read the foregoing waiver of liability and hold harmless agreement, understand it and voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement have been made. I am the parent\guardian of the child registered on this form and am fully competent. I execute the release for full, adequate, and complete consideration fully intending to be bound by the same .
